## About Barts Charity

We're a charity dedicated to supporting improvements to healthcare and transformative research which benefits 2.5 million people in East London and beyond. We do this by funding high quality, ground-breaking research, innovative patient care projects and NHS staff wellbeing initiatives that would not otherwise be funded by the NHS or other grant funders.

We mainly award our funding to Barts Health NHS Trust (which runs St Bartholomew's, The Royal London, Mile End, Whipps Cross and Newham Hospitals) and to the Faculty of Medicine & Dentistry (part of Queen Mary University London) where there are six medical research institutes. We also support researchers at City, University of London School of Health Sciences.

We make new awards totalling ~£30m each year. Among NHS Charities we are the second largest funder and by research spend are in the top five funders of medical research among members of the Association of Medical Research Charities.

We are approximately 35 staff, based in Smithfield (Farringdon). Our teams comprise Funding & Impact, Fundraising, Marketing & Communications, Finance, and Operations.

#### About the role

This is an exciting time to be joining Barts Charity as we have recently launched our 2022-2027 Strategy, including several new activity areas and revised funding schemes. Our new strategy will continue our significant £30 million per year funding programme and deliver on ambitious fundraising and public awareness campaigns.

The Funding Manager (Research) role will be key in making sure we fund impactful research projects. This includes making the most of our funding resources by facilitating the assessment and funding of new grants, managing a proportion of our current research funding portfolio, and contributing to monitoring progress of a range of research projects.

You will be an integral part of the busy and ambitious Funding & Impact team and work closely with a number of other Charity teams. You'll build relationships with the healthcare professionals and researchers at Barts Health NHS Trust and the Faculty of Medicine and Dentistry, QMUL.

With your research funding expertise, this is an exciting opportunity to put your stamp on a new role as we embark on our new 5-year strategy.

## About you

- You will demonstrate an understanding and have experience of funding and grant-giving, and the role of charities in supporting healthcare and research.
- You will demonstrate knowledge and show an understanding of biomedical and/or clinical research in a Higher Educational Institution (HEI), life sciences or healthcare sector.
- You will have experience of supporting the development of successful projects, ideally within a HEI, NHS or healthcare setting.
- You will have excellent communication and interpersonal skills alongside the ability to build strong relationships with a wide range of internal and external stakeholders, including research staff, health professionals, healthcare delivery staff and third sector organisations.
- You will be able to think creatively and problem solve, sometimes in a challenging and fast paced environment, alongside having an analytical mind-set and excellent attention to detail.
- You will be passionate and motivated by a desire to support healthcare professionals and scientists to deliver the next discoveries and to translate them into healthcare improvements for a patient population.

## Key areas of responsibility

#### **Grants Development and Assessment**

- Proactively work with our partner organisations to develop opportunities for Grant support, promote the Charity's grant schemes and strategy within our partner organisations, provide advice and answer queries to potential applicants, and support applicants throughout the grants application process.
- Manage and deliver the grant application process across the breadth of our research grants, including
  assessing and carrying out due diligence on the case for support, long term plans for sustainability, costs
  requested and case for potential benefits and impact.
- Lead on the running and delivery of a subset of funding schemes, with Head of Research Funding oversight.
- Ensure suitable information is available for advisory and decision-making meetings associated with research-related grants including the preparation of committee papers.
- Be responsible for ensuring high-quality advice is sought on research funding requests, e.g. through formal partner groups, external peer-review, expert opinion, Barts Charity Scientific Review Panel.
- Ensure meaningful and appropriate patient and public involvement is embedded within Research funding applications and the Charity's equality, diversity and inclusion expectations are upheld.
- Work with stakeholders at our partner organisations and across the Charity to facilitate optimum and impactful use of Special Purpose Funds (restricted funds) held by Charity in line with Charity strategy and relevant to Research funding.

## Key areas of responsibility cont'd

#### **Funding and Grants Management**

- Manage funded grants to facilitate successful set-up and ongoing delivery including working with finance team on grant payments, ensuring prior conditions of award are met and the Charity supports delivery where possible.
- Assess and facilitate progress of awarded Grants though contact with Grant holders, partner stakeholders and through the charity's monitoring and impact process.
- Play a key role in post-award monitoring of grants award by the charity, undertake analysis of progress/final reports to analyse outcomes and outputs arising from charity funded projects and identify any emerging trends or patterns.
- Support the management and continuous improvement of grant management systems and associated data to support funding operations and funding monitoring and impact assessment.

#### **Strategy Delivery**

- Work closely with the Director of Funding & Impact and Head of Research Funding to support Charity strategy delivery, and underlying delivery plans, in the area of Research Funding.
- Contribute broadly and impactfully to the wider Funding & Impact team activity team
- Actively horizon-scan and provide insight on research sector developments



## Key areas of responsibility cont'd

#### Relationship Management/Stakeholder Engagement

- Proactively build relationships with staff members at our partner organisations, and with external organisations to support delivery of the Charity's mission.
- Work with Marketing & Communications and Fundraising teams to help communicate the activities of the Charity.
- Represent the Charity at external meetings, promote the Charity's funding schemes, opportunities and strategy within BH/SMD/City University and network with external stakeholders and other external organisations to help deliver the Charity's goals.

#### <u>General</u>

- Ability to keep up to date with current research policy and funding within the UK and understand its implications on Universities, NHS healthcare providers, delivery staff and patients.
- Produce reports for the Director of Funding & Impact, Head of Research Funding, Trustees and other teams as required.
- Liaise with relevant departments to troubleshoot for success should issues arise.
- Undertake work in accordance with Barts Charity policies and principles.
- Undertake any other duties that may be required from time to time.

## Professional development


